## FOURTH LUMINOUS MYSTERY: THE TRANSFIGURATION OF THE LORD

My dear Sisters and Brothers,

If any of the Mysteries of the Rosary deserves to be called luminous, it is the Transfiguration of Jesus Christ. The Transfiguration is one of the five major milestones in the gospel narrative of the life of Jesus, the others being Jesus' Baptism, Crucifixion, Resurrection, and Ascension. Where Jesus' Baptism in the Jordan River marked the beginning of Christ's ministry and the Ascension would mark the end, the Transfiguration was the culminating point. The event, which is recorded in the gospels of Matthew, Mark and Luke, and referred to in the gospel of John, is the fourth Luminous Mystery. The Fruit of this Mystery is a "desire for holiness." The miracle of the Transfiguration is unique as instead of Jesus performing a miracle, it is a miracle that happens to Jesus himself.

Since the wedding feast at Cana, the gospels tell of the miracles Jesus continued to perform. Jesus also began to prepare his disciples for what was ordained to be as he foretold his own death just days before the Transfiguration. The apostles did not want to hear of it. They had been faithful followers

for almost three years and witnessed Jesus' many miracles. To their way of thinking, surely if Jesus was the chosen Messiah, he would not die. Perhaps they even began to wonder if he really was the Messiah.

Jesus decided to take Peter, James and John up a high mountain to pray with him. Although there is no mention in the Bible of which mountain, it is believed to be Mount Tabor. While there, nightfall was coming upon them, and as Jesus kept praying, the three apostles fell asleep. Suddenly they were awakened by what was taking place as Jesus was transfigured before them. Christ's face "became as dazzling as the sun, his clothes as radiant as light" (Mt. 17:2). From the brightness came the sound of voices. The disciples saw that Jesus was conversing with Moses and Elijah about the trials that awaited Jesus in Jerusalem. The presence of Moses and Elijah is best interpreted as indicating that Jesus was the fulfillment of everything taught by these two, with Moses representing the Law and Elijah representing the Prophets. Seeing this, Peter was somewhat dumbfounded and

asked if Jesus wished three tents to be put up for them. Just then a bright cloud came over all and from the cloud came a voice that said, "This is my beloved Son, with whom I am well pleased; listen to him" (17:5). This is the second time where God the Father proclaims that Jesus is His Son and admonishes us to listen to him; the first time being at Jesus' Baptism in the River Jordan. Hearing this voice the three disciples fell to their knees and were very afraid, but Jesus touched them and reassured them not to fear. When they raised their eyes, only Jesus stood before them and all had returned to as before. As they came down from the mountain, Jesus, wishing to preserve the secret that he was the Messiah until the prescribed time that was foreordained, said, "Tell no one the vision until the Son of Man is raised from the dead" (17:9). The disciples did as Jesus asked although being somewhat confused as to what exactly Jesus meant.

The Transfiguration was intended to strengthen the faith of the disciples and to confirm what Jesus had told them days earlier. Christ was preparing them and fortifying their faith for the coming agonizing struggle of the Passion of which they were to be witnesses. At the same time the vision at the Transfiguration gave them a small sample of the heavenly glory which can be attained by suffering.

This Advent as we prepare for the anniversary of Christ's birth, may we all fervently commit ourselves to the Faith we profess and may we be more dedicated to the work that God calls us to in our daily life. Let us draw encouragement and inspiration from the account of the Transfiguration of Jesus Christ and respond to the invitations of grace in our daily lives in order to grow more fully into the image and likeness of Jesus Christ, our Savior.



## FCSLA Bylaw Changes

At the 42nd National Convention, the Convention ratified a several minor changes to our corporate Bylaws.

### 1. Quadrennial Convention Election Process

Article V. A. 4. (f) (i) was amended to permit voting through "electronic voting means" (versus secret ballot). Article V. A. 4. (f) (ii) was amended to delete the words "secret ballot" (to be consistent with Article V. A. 4. (f) (i)). Article V. A. 4. (f) (i) was also amended to provide that "A delegate may choose to request a paper ballot instead of an electronic ballot."

### 2. Quadrennial Convention Election Process

Article V. A. 4. (h) regarding the first Board meeting after a Quadrennial Convention was amended by striking out the words "Quarterly Board" (leaving just the word "meeting" to describe the meeting).

### 3. Special Conventions

Article V. B. 1. was amended by lengthening the time a Special Convention that is called upon the demand of a majority of the Senior Branches shall be held. The time period was extended from sixty (60) days to ninety (90) days.

### 4. Convention for Mergers and Acquisitions

Article V. C. 2. revised the manner in which notification of a Special Convention pertaining to a merger, asset acquisition or membership acquisition is provided to Senior Branches and delegates. The revision provides that notice "shall be determined by the managing officers and approved by the Board of Directors." This replaced the provision that notice was to be given "in the same manner as for the Quadrennial Convention."

Article V. C. 3. regarding the time limit ballots must be returned in a Special Convention pertaining to a merger, asset acquisition or membership acquisition was amended by providing ballots must be returned "ninety (90) days after mailing." The previous version required the ballots be returned "sixty (60) days after receipt."


## 42nd Annual Saints Cyril and Methodius Appeal Update


## Stephen J. Mikulas, S107

# Family Holiday Favorites



## ORECHOVNIK (NUT ROLLS)

*For the Dough:*

- 1 teaspoon sugar
- ½ cup warm water
- 2 ounces cake yeast or 3 packets (6¾ teaspoons) active dry yeast
- 6 eggs
- 16 ounces sour cream
- 2 cups unsalted butter, melted and cooled
- 1 cup granulated sugar
- 1 teaspoon vanilla extract
- ½ teaspoon salt
- 9 to 10 cups grams all-purpose flour

*For the Filling:*

- 3 pounds walnuts (finely ground)
- 3 cups granulated sugar
- ¾ cup unsalted butter, melted and cooled
- ¾ cup evaporated milk
- ½ cup whole milk
- ½ teaspoon vanilla extract

*Make the Dough:* Dissolve 1 teaspoon sugar into the ½ cup warm water (if using fresh cake yeast, the water temperature should be between 90 to 95 degrees; if using active dry yeast, the water temperature should be 120 to 130 degrees). Crumble the fresh yeast or sprinkle the active dry yeast and stir to combine. Let sit for 5 to 10 minutes, or until foaming.

In the bowl of a stand mixer using the paddle attachment, beat the eggs on medium speed until combined, about 1 minute. Add the sour cream, melted butter, sugar, vanilla, salt and the softened yeast. Mix on medium speed until smooth and well-combined, about 2 to 3 minutes. Switch to the dough hook, reduce the mixer speed to low, and add the flour a little at a time, until the dough does not feel sticky but is still soft and supple. Continue kneading until the dough does not stick to the sides of the bowl. Cover with a damp dish towel while you prepare the filling.

*Make the Filling:* In a large bowl, combine all of the ingredients for the filling, stirring well to ensure that it is completely mixed and all of the ingredients are incorporated.

*Assemble the Nut Roll:* Line four baking sheets with parchment paper or silicone baking mats. Divide the dough into eight pieces. On a clean work surface and one at a time, roll each piece out into a 9x14-inch rectangle, using flour if necessary to keep

from sticking. Spread one-eighth of the filling to within ½-inch of the edges. With the long side in front of you, roll up gently and pinch the seams shut. Place on the prepared baking sheets, 2 rolls per sheet. Cover loosely with plastic wrap. Repeat with all eight pieces of dough. Place the baking sheets in a draft-free area and allow to rise for 3 hours (the rolls will puff and swell but will not look huge).

*Bake the Nut Roll:* Preheat oven to 350 degrees F. Bake one pan at a time for 20 to 25 minutes, or until the tops are lightly browned. Cool completely before slicing. Wrap leftovers tightly in plastic wrap and store at room temperature for up to 1 week. The nut roll can be frozen by wrapping in plastic wrap, then again in foil, and stored in the freezer for up to 2 months. Thaw at room temperature.

This recipe can be cut in half to make only four rolls instead of eight.

## KOLACKY

- 6 ounces cream cheese, softened
- 1 cup butter
- 2 cups all-purpose flour
- 2 tablespoons white sugar
- ¼ teaspoon salt
- 2 teaspoons baking powder
- 1 (21 ounce) can apple pie filling
- 2 tablespoons confectioners' sugar

Preheat oven to 350 degrees. Lightly grease cookie sheets.

Using a pastry blender or food processor, cut butter into cream cheese.

In a small bowl, sift dry ingredients together except for confectioners' sugar.

Work dry ingredients into butter/cream cheese mixture until you have an even, mealy texture.

Knead to form a stiff dough. If the dough gets too soft, refrigerate for about five minutes before continuing.

Roll dough to ¼-inch thickness.

Using a cookie cutter or glass, cut into about 3 inch diameter cookies. Keep re-rolling dough until you have used it all. Use your thumb to make a depression in each cookie. Place a ½ teaspoon of filling in the depression.

Bake for about 20 minutes (until lightly golden). Let cool on a cookie rack. Dust lightly with confectioners' sugar. Store in an airtight container.

## SWEET CABBAGE STRUDEL

- ½ cup raisins
- 4 tablespoons (½ stick) unsalted butter, plus 8 tablespoons (1 stick), melted
- ¼ cup sugar
- 3 tablespoons fresh lemon juice (from 1 lemon)
- 1 tart apple, peeled and grated (can hold it in water to avoid discoloring)
- 5 cups shredded green cabbage (from ½ head)
- ¼ teaspoon salt, plus more as needed
- ½ cup sour cream, plus more for serving
- 10 sheets phyllo dough (about 7 ounces; defrosted if frozen)
- ¼ cup finely crushed dried bread or cracker crumbs

Preheat the oven to 350 degrees. Use cooking oil spray to grease a baking sheet.

Place the raisins in a small bowl and cover with hot water; let sit for 10 minutes, then drain.

Melt the 4 tablespoons of butter in a large saute pan over medium heat. Stir in the sugar and lemon juice; cook for 2 minutes until the sugar has dissolved.

Stir in the apple, cabbage and ¼ teaspoon salt. Cover and cook for 5 minutes, then uncover and increase the heat to medium-high; cook for 3 to 4 minutes, stirring, so much of the excess moisture evaporates.

Let cool slightly. Taste and season with more salt, as needed. Stir in the raisins and sour cream, then taste again for salt.

Place 1 sheet of the phyllo dough on a clean, damp kitchen towel. Brush with some of the melted butter, then sprinkle lightly with some of the crumbs. Repeat this layering 4 more times.

Spread half the cabbage mixture across a narrow end of the dough, leaving a 1 ½-inch border on both sides and a 4-inch border on the top. First, fold in the side borders, then fold down the 4-inch border.

Use the edge of the kitchen towel to help guide/roll the filled phyllo into a log/strudel. Transfer it to the baking sheet, seam side down.

Repeat with the remaining butter, phyllo, crumbs and cabbage filling, to roll and create the second strudel. Transfer to the baking sheet, alongside the first strudel. Brush the tops of both strudel with any remaining melted butter.



Bake (middle rack) for about 40 minutes, or until the strudels are crisped and golden brown. Let cool for at least 5 minutes before cutting.

### **PALACINKY**

- 2 cups skim milk
- 6 eggs, beaten
- 1 cup all-purpose flour
- ¼ cup white sugar
- 1 teaspoon vanilla extract
- ½ cup canola oil, or as needed

Beat milk, eggs, flour, sugar, and vanilla extract together in a large mixing bowl until the batter is thin and without lumps.

Heat a large skillet over medium heat and grease with 1 tablespoon canola oil. Ladle enough batter into the skillet to cover the cooking surface in a thin layer. Cook until bubbles appear on the surface, 2 to 3 minutes. Flip with a large turner and cook until browned on the other side, about 2 minutes more.

Remove cooked palacinky to a plate and roll into a log.

Sprinkle with powdered sugar, fruit syrups or whipped cream, if desired.

### **EGGNOG CHEESECAKE**

- 1 cup graham cracker crumbs
- 2 tablespoons white sugar
- 3 tablespoons melted butter
- 3 (8 ounce) packages cream cheese, softened
- 1 cup white sugar
- 3 tablespoons all-purpose flour
- ¾ cup eggnog
- 2 eggs
- 2 tablespoons rum
- 1 pinch ground nutmeg

Preheat oven to 325 degrees.

In a medium bowl combine graham cracker crumbs, 2 tablespoons sugar and butter. Press into the bottom of a 9 inch spring form pan.

Bake in preheated oven for 10 minutes. Place on a wire rack to cool.

Preheat oven to 425 degrees.

In a food processor combine cream cheese, 1 cup sugar, flour and eggnog; process until smooth. Blend in eggs, rum and nutmeg. Pour mixture into cooled crust.

Bake in preheated oven for 10 minutes.

Reduce heat to 250 and bake for 45 minutes, or until center of cake is barely firm

to the touch. Remove from the oven and immediately loosen cake from rim. Let cake cool completely before removing the rim.

### **MELT IN YOUR MOUTH HONEY LEMON CHRISTMAS COOKIES**

- ⅓ cup white sugar
- 1 egg
- ⅔ cup honey
- 1 teaspoon lemon extract
- 2¼ cups sifted all-purpose flour
- 1 teaspoon baking soda
- 1 teaspoon salt

Mix sugar, egg, honey, and lemon in a medium bowl with mixer. Sift together and stir in flour, soda, and salt. Chill dough for 1 hour.

Preheat oven to 375 degrees.

Roll out ¼ inch dough and cut shapes using flour to roll and cut. Place on greased cookie sheets. Bake for 8-10 minutes. Do not let cookies get brown. Follow by icing with lemon buttercream icing.

### **LEMON BUTTERCREAM FROSTING**

- 3 cups powdered sugar
- ⅓ cups butter or margarine, softened
- 3 tablespoons lemon juice
- ½ teaspoon grated lemon peel

Beat butter, lemon peel and lemon juice in medium bowl with electric mixer on medium speed 30 seconds. Gradually beat in powdered sugar. Beat 2 to minutes longer or until light and fluffy.

### **CHOCOLATE RUM BALLS**

- ¾ cups crushed vanilla wafers
- ¾ cup confectioners' sugar
- ¼ cup unsweetened cocoa powder
- 1½ cups chopped walnuts
- 3 tablespoons light corn syrup
- ½ cup rum

In a large bowl, stir together the crushed vanilla wafers, ¾ cup confectioners' sugar, cocoa, and nuts. Blend in corn syrup and rum.

Shape into 1 inch balls, and roll in additional confectioners' sugar. Store in an airtight container for several days to develop the flavor. Roll again in confectioners' sugar before serving.

### **SPIKED EGGNOG**

- 12 eggs, separated
- 3 cups white sugar, divided
- 16 fluid ounces dark spiced rum
- 1 teaspoon ground nutmeg
- 2 cups heavy whipping cream
- 1 quart half-and-half

Mix egg yolks, 2 cups sugar, rum, and nutmeg together in a large bowl. Cover with plastic wrap and refrigerate 8 hours to overnight to "cure."

Beat egg whites and remaining 1 cup sugar in a bowl using an electric mixer until firm peaks form. Fold in heavy cream. Fold in the egg yolk mixture. Beat in half-and-half until well combined. Pour into lidded jars or containers, refrigerate, and shake before serving.

### **COCONUT BUTTERSCOTCH FUDGE COOKIES**

- 1 pouch (1 lb. 1.5 oz) sugar cookie mix
- ½ cup butter or margarine, melted
- 1 egg
- 1 to 1½ cups flaked coconut
- ½ cup butterscotch topping
- ¾ cup hot fudge topping

Heat oven to 375 degrees. In large bowl, stir cookie mix, melted butter and egg until soft dough forms. Shape dough into 1-inch balls. Roll balls in coconut. On ungreased cookie sheets, place balls 2 inches apart.

Bake 9 to 11 minutes or until edges are light golden brown and coconut starts to toast. Cool 3 minutes; remove from cookie sheets to waxed paper.

Drizzle each warm cookie with butterscotch topping. In small microwavable bowl, microwave hot fudge topping uncovered on High 15 to 30 seconds or until spreadable. Carefully spread on top of each cookie. Serve warm or cool. Store loosely covered.
