# FRUIT OF THE HOLY SPIRIT: MILDNESS

My dear Sisters and Brothers in Christ,

Throughout my life and my priestly ministry, I have encountered so many people who I have believed to be examples of living Faith by whom I should model my own Catholic Faith life. You know the people I am speaking of – those we have thought to be ones we should be able to imitate and follow in order to make our Faith more of a reality. I look to the popes of my era: Pius XII, John XXIII, Paul VI, John Paul I and John Paul II. These were spiritual, powerful men who led the Church through the challenging times in the Church and throughout the world. I admire religious figures like Archbishop Oscar Romero and Mother Teresa of Calcutta who had the courage to stand up for the dignity and rights of the ones in whom they were entrusted to serve. What personalities we have experienced who had the ability to live their Faith so ardently in the Name of Jesus.

These internationally known Catholic figures of the immediate past history of the Church became endeared to those of us in the Church and people outside the Church not only because of their outstanding leadership but also what Gift of the Spirit they attempted to live to the best of their abilities, i.e., mildness, or what we also call humility. These noble servants walked among us and before God and humbly did the work of the Lord. Although we were unable to be physically in touch with them, they were and are spiritual guides for us in walking our journey of Faith humbly before the Lord. There are those who do live among us that are examples to assist us in a life of humility.

Primarily, I look to Jesus. He is among us and He teaches us humility. The author of the *Gospel of Matthew* writes: "On one occasion Jesus spoke thus: 'Father, Lord of heaven and earth, to you I offer praise; for what you have hidden for the learned and clever you have revealed to the merest children. Father, it is true. You have graciously willed it so. Everything has been given over to me by my Father. No one knows the Son but the Father, and no one knows the Father but the Son – and anyone to whom the Son wishes to reveal him. Come to me all you who are weary and find life burdensome, and I will refresh you. Take my yoke upon your shoulders and learn from me, for I am gentle and humble of heart. Your souls will

find rest for my yoke is easy and my burden light" [11:25-30]. What words the Saviour gives us as a direction for our lives. Our ability to know the Father is through Jesus and to know Jesus is through the Father. But to do so, we know them as children in humble knowledge and acceptance. Through this humble knowledge and acceptance, we learn to do the Father's will by being like Jesus – taking up our burdens of the Cross that we share with Him and humbly accept them as did He. He will show us that although the Cross may be difficult to bear, He will be there to make it easy and light. We are called to be servants just as Jesus was called to be servant to the Father for us.

I look to the people with whom I minister and to whom I minister the Gospel as models of mildness to me. They are not as distant as the Apostles and saints that have gone before us or like those holy personalities of our immediate past history of our Church. These that I think of and rely on are living models for me to place my life in the proper perspective of being a humble servant before the Lord and humanity.

I am awestruck by the men and women of my parishes who serve faithfully at our Saint Vincent de Paul sponsored soup kitchen for one week in the spring and one week in the fall. There is no need for me to organize who will go when or if there are enough people to serve and cleanup each week. They make their schedules among themselves, their time and talents and their names are not widely known in the parish. They perform this corporal work of mercy because it is important to humbly serve the needs of those so less fortunate than ourselves. In doing so, they appreciate all the more what the Lord has given to them. They desire to share the Cross of the less fortunate in this manner of humble service.

I appreciate the many people hours parishioners give to promote the Gospel of Jesus Christ by sharing their message with others in our parishes – educators in our parish grade schools and schools of religion, youth ministry programs, education sessions, the RCIA and the list may go on and on when it comes to bringing the Gift that has been handed down. In mildness, they share it with others and make sure our young people and Faith searching adults understand the precious

gift that is in our midst through the Passion, Death and Resurrection of Jesus.

Although they may not view their activities as mildness to the parish family and beyond, our parish organizations serve the needs of the parish through the charisma that each one has as their goal. In most instances, their work is accomplished in the humility of Christ. Whether it is for the better of liturgical celebrations, the assistance of parishioners and neighbors in need, the building up of Christian unity, the financial needs of the parish, helping fellow parishioners in the time of death, etc., I am humbled by their commitment to Almighty God and the Church.

But I am most humbled by the women and men who regularly commit themselves to our God in their lives of prayer, especially in the weekly celebration of the august sacrament of the Eucharist. What we do in that celebration on Sundays reminds us of what Catholics have done for two thousand years in their commitment to Jesus Christ – acknowledging Him as our Lord and Resurrected Saviour. What we take from that celebration each week, is to be Him to others all the other days of the week. How we have performed in our humble service to the Lord and one another, is the Gift and need of forgiveness we place before the altars of His Word and Sacrament. We thank God humbly for what we have done; we humbly seek grace-filled strength to do more.

Our ultimate model of mildness is Jesus. Saint Paul reminds us of who Jesus is for us as that model of humility. In his *Letter to the Philippians* he writes, "Though he was in the form of God, Jesus did not deem equality with God something to be grasped at. Rather, he emptied himself and took the form of a slave, being born in the likeness of men. He was known to be of human estate, and it was thus that he humbled himself, obediently accepting even death, death on a cross! Because of this, God highly exalted him and bestowed on him the name above every other name. So that at Jesus' name every knee must bent in the heavens, on the earth, and under the earth, and every tongue proclaim to the glory of God the Father: Jesus Christ is Lord! [2:6-11] Let us be humble servants of our God!

## The Members' Corner

The convention is just around the corner. It is an exciting time for us. We have passed the 650 million dollar mark for our assets. Let's celebrate! Let's keep our conversation going.

**Q As a member, I have recently heard that we will lose our power to choose our own candidates for the managing officers with the current proposed Board's bylaw change. Is this true?**

**A** No, you will not lose your power in the selection of qualified candidates for the positions of the managing officers. In the Board's bylaw proposal from last year, specific qualifications would be determined to fit the unique responsibilities of the different positions of these managing officers. These criteria will reflect the individuality of the positions within our own society. Your power will continue because you will be in charge of putting into office the most important people — those who will assess the performance of the persons in these key positions.

**Q If changes to the way we choose our managing officers are approved according to the Board proposal presented in the Special Convention, when will they become effective?**

**A** According to Robert's Rules of Order (RRO), an amendment to the bylaws goes into effect immediately upon its adoption unless the motion to adopt specifies another time for its being effective.

**Q I often see the terms "revisions" and "amendments" in reference to bylaws. Is there any difference?**

**A** Great question! They are actually *very* different. A revision is the name given to a complete reworking of the bylaws and (according to Roberts Rules of Order) is undertaken only when **authorized** by a Board of Directors or a Convention. RRO directs the appointment of a large subcommittee to prepare a first draft to be further reviewed and critically examined by the full committee to make certain that all

groups within the organization are included and served. **Only** when the finished bylaws, through this revision, have been thoroughly analyzed by the full committee should the document be presented to the convention and discussed section by section before it is submitted for approval by that body.

An amendment, on the other hand, is a change to a limited portion of the bylaws document. Unlike a revision, a committee does not need to be appointed to review the document and the amendment can be presented and handled in much less time. When the amendment is presented, the pros and cons are discussed and a vote is taken on that one item.

As we approach the time of the convention, allow me to thank you for your genuine interest in our society's future, demonstrated by the flow of thought provoking questions over the past few months. I truly appreciate the time you took to prepare questions and send them to me.





## ~ FRESH FIT FOR FCSLA ~

In the August Fraternally Yours 'Members Corner', a question was asked about a different bylaw proposal than was presented at the special convention. There is an alternative. The idea was submitted to the bylaw committee by several members, branches and districts, including the Pittsburgh District and accompanied by in excess of 200 signatures.

The new proposed amendment came about because we recognize the strong desire within our membership, to participate to the fullest extent possible, in selecting our leadership. Also, the plan presented at the special convention had deficient and incompatible language which was un-workable.

We all agree that it takes qualified people to carry out FCSLA's operations. However, there is no 'One Size Fits All' plan for every fraternal. Thus, board members Bernadette Demechko, Virginia Holmes, Linda Killeen and Dorothy Urbanowicz prepared an amendment, with suggestions from the District Presidents of Illinois, Indiana, Pittsburgh and Youngstown.

This proposed amendment has the following changes:

- 1) Requires qualifications for managing officer and Board of Director positions.  
For example, it stipulates that relevant work experience is essential; the National Treasurer is required to be a CPA; the National President must have a college degree. These qualifications are shown in the bylaws for transparency.
- 2) Entrusts the Board of Directors to screen the 'Intent to Run' applications of the managing officers (ie. President, National Treasurer, and National Secretary). The Board of Directors will ensure that candidates for these positions meet the pre-established qualifications.
- 3) **The convention will retain the power to elect** managing officers and the Board of Directors, from a 'slate' of qualified candidates.
- 4) It removes the managing officers from the Board of Directors. This will allow the Board of Directors to make un-biased evaluations of management's performance, and makes management directly accountable to the Board.
- 5) It creates a 'Non-Voting Delegate'. This gives all qualified members of the Society, the opportunity to seek office. Qualified members will not be prevented from running for office simply because a branch nominates only friends and family members to be convention delegates.

**The Ohio Department of Insurance recommended that our fraternal take steps to establish pre-requisites for officer nominees**, which demonstrate they have the background, knowledge and experience to direct and manage the Association's operations. The plan presented at the October 2010 Special Convention, had no qualifications for the President, Treasurer, and National Secretary. Nor did it have qualifications for the Board of Directors who would be

responsible for selecting, hiring and evaluating the managing officers.

At our upcoming October convention, we must make a decision on how to acquire and place qualified people into all governance positions. A bylaw change will need the approval of two thirds of the convention delegates. Hopefully, this revised plan can bring the majority of delegates together in an agreement to move forward on the governance issue.

The festival started off with an ecumenical blessing and parade of flags, followed by a blessing of the various food





# SCF MID-YEAR ANNUAL APPEAL REPORT

Since 1978, the Slovak Catholic Federation has been conducting the annual SS. Cyril and Methodius Appeal, which begins each year in the month of February during the closest weekend to the Feast of SS. Cyril and Methodius. The appeal continues during the entire calendar year. Now in its 33rd year, this appeal has primarily been taken up in parishes of Slovak heritage in the United States and Canada. To date, I am happy to report that **\$22,111.64** has been collected for the 2011 appeal.

As we are all very much aware, "ethnic parishes" are becoming a thing of the past. More and more Slovaks reside in different parts of the country and no longer claim to belong to a parish of Slovak heritage. For this reason, many Slovaks may not have the opportunity to hear about, let alone participate in, this annual appeal. If it were not for the Slovak Catholic fraternal societies and their publications, communication to American and Canadian Slovaks would not be possible. In recent years, we have seen an increase in individual donations apart from the parish collections. Also, most of the Slovak fraternal societies have also been making contributions to this collection from their national board of directors, along with a number of local branches, wreaths, assemblies, and lodges.

As many of you know, this appeal assists the Church in Slovakia by supporting the training mission of the Pontifical Slovak College of SS. Cyril and Methodius in Rome, Italy (formally known as the Slovak Institute or *Ustav*). In addition, funds are distributed to those religious communities of both men and women that share a counterpart which belongs to the Slovak Conference of Religious. These communities include the Vincentian Sisters of Charity (*Ruzomberok*), Dominican Sisters (*Dunajska Luzna*), School Sisters of St. Francis (*Zilina*), Daughters of St. Francis (*Bratislava-Prievoz*), Byzantine Catholic Sisters of St. Basil the Great (*Secove and Presov*), Franciscan Friars Minor (*Bratislava*), and House of St. Benedict (*Bacurov*).

As various groups will be holding summer picnics and/or national conventions, I ask that consideration be given to kindly taking up a collection in support of the Slovak Catholic Federation Appeal. All donations are tax deductible. In 2010 this annual appeal raised **\$58,229.89**.



## Fresh & Healthy!

### PEAR AND GREENS SALAD WITH MAPLE VINAIGRETTE

#### **Vinaigrette:**

- ¼ cup real maple syrup or maple-flavored syrup
- 2 tablespoons balsamic vinegar
- ½ teaspoon Dijon mustard
- ¼ teaspoon salt
- ¼ teaspoon pepper
- ¼ cup canola or vegetable oil

#### **Salad:**

- ⅓ cup pecan halves
- 8 cups torn mixed salad greens
- 3 medium pears, peeled, cut into wedges
- ⅓ cup sweetened dried cranberries

In small bowl, mix all vinaigrette ingredients except oil with wire whisk. Beat in oil until well blended.

Place pecans in 1-cup glass measuring cup. Microwave on high 2 minutes to 2 minutes 30 seconds, stirring every 30 seconds, until browned.

Divide salad greens among 6 serving plates. Arrange pear wedges on greens; sprinkle with pecans and cranberries. Drizzle vinaigrette over salads. Serves 6.

### GRILLED FISH WITH TANGERINE & MARJORAM

- 2 (1¼) pound whole porgy, gray snapper, or branzino, cleaned
- Kosher salt and freshly ground black pepper

- 8 sprigs fresh marjoram plus 1 tablespoon marjoram leaves
- 2 tangerines or small oranges, peeled, separated into segments, seeded
- 2 tablespoons olive oil

Prepare a medium-hot fire in a charcoal grill, or heat a gas grill to medium-high. Make 3 diagonal slices spaced about 1½" apart on each side of fish. Season skin and cavity with salt and pepper. Stuff each fish with 4 herb sprigs and segments from ½ tangerine. Rub each fish with 1 tablespoon oil.

Grill fish until skin no longer sticks, 3-4 minutes. Using a metal spatula, carefully turn fish and grill until cooked through, about 3-4 more minutes. Transfer to platters and garnish with remaining tangerine segments and marjoram leaves. Serves 2-4.

### MINIATURE CRAB CAKES WITH MUSTARD MAYONNAISE

#### **For crab mixture:**

- ½ cup minced red bell pepper (about 1 small)
- 1 teaspoon vegetable oil
- ⅓ cup mayonnaise
- 1 large egg yolk
- 1½ tablespoons stone-ground mustard
- 1 to 2 teaspoons fresh lemon juice
- ¾ teaspoon dried tarragon, crumbled
- 1 pound jumbo lump crab meat, picked over
- 1½ cups panko (Japanese flaked bread crumbs)

#### **For mustard mayonnaise:**

- ¼ cup mayonnaise
- 2½ teaspoons stone-ground mustard
- ¼ teaspoon fresh lemon juice, or to taste
- ½ stick (¼ cup) unsalted butter, melted

#### **Crab mixture:**

In a small non-stick skillet sauté bell pepper in oil over moderately high heat, stirring, 2 minutes, or until softened and golden. In a bowl whisk together mayonnaise, yolk, mustard, lemon juice, tarragon, and bell pepper and stir in crab and salt and pepper to taste gently but thoroughly. Chill crab mixture, covered, at least 1 hour and up to 1 day.

Preheat oven to 350 degrees. In a large shallow baking pan spread panko bread crumbs in even layer. Toast panko, stirring occasionally, until golden, about 10 minutes, and cool. (Panko may be toasted 1 week ahead and kept in an airtight container at room temperature.)

Form rounded teaspoons of crab mixture into slightly flattened 1-inch rounds and gently coat with panko, transferring

to a shallow baking pan. Chill crab cakes, loosely covered with wax paper, at least 2 hours and up to 4.

#### **Mustard mayonnaise:**

In a small bowl whisk together mayonnaise, mustard, and lemon juice. (Mayonnaise may be made 3 days ahead and chilled, covered.)

Preheat oven to 450 degrees. Drizzle a scant ¼ teaspoon butter on each crab cake and bake in middle of oven until crisp and cooked through, about 15 minutes.

Serve crab cakes with mustard mayonnaise.

### CHERRY TOMATO PIZZA MARGHERITA

- 1 13.8-ounce tube refrigerated pizza dough
- 1 tablespoon extra-virgin olive oil
- 1 12-ounce bag cherry tomatoes, stemmed
- 1 garlic clove, pressed
- ½ teaspoon fennel seeds, coarsely crushed in plastic bag
- ¼ teaspoon dried crushed red pepper
- 1 4-ounce ball fresh mozzarella in water, diced
- 4 ounces whole-milk mozzarella, diced
- ⅓ cup chopped fresh basil leaves plus small leaves for garnish

Position rack in top third of oven and preheat to 425 degrees. Unroll dough on heavy large baking sheet; pull to about 12x8-inch rectangle, pinching any tears to seal. Fold over edge of dough to make border.

Heat large skillet over high heat 2 minutes. Add oil, then tomatoes; sprinkle with salt and pepper. Sauté until tomatoes are charred and beginning to break down, about 5 minutes. Transfer to large bowl. Mix in garlic, fennel, and crushed red pepper. Using back of fork, crush tomatoes in bowl, leaving large chunks intact. Season mixture with salt and pepper. Toss cheeses and chopped basil in medium bowl.

Sprinkle cheese mixture evenly over dough, right up to border. Spoon on tomato mixture in dollops, leaving some cheese uncovered. Bake pizza until crust is crisp and brown, 25 to 30 minutes.

Loosen pizza with metal spatula and slide onto serving tray. Garnish with basil leaves.
